The International Certified Vocational Evaluator (ICVE) credential application process is described in the chart below.

* If self-employed, must submit job description, résumé/CV, and three letters of reference.

All must show proof of professional liability insurance, federal criminal background check, and complete college jurisprudence (terms and conditions of ICVE certification).

Application Cost including Examination: \$425.00 Canadian (approximately \$313 USD). If you pay with a credit card, your card company will make the appropriate exchange based on the daily rate.

ICVE Certification Maintenance

40 CEUs (6 ethics CEUs) will be required over a two-year period
